NOTIFICATION

Whereas in pursuance of the provisions of sub-section (1) of section 3 of the Pondicherry Municipalities Act, 1973 (Act No. 9 of 1973) a proclamation announcing the intention of the Government to declare the entire local area under the jurisdiction of Oulgaret Commune Panchayat to be a Municipality was issued in Development Department (LA) a Notification in G.O.No. 8/93-94/LAS, dated 23rd April, 1993 and published in Gazette of Pondicherry Part I Extraordinary No.40, dated 29th April, 1993 inviting objections from the resident or tax payers of the Oulgaret Commune Panchayat area in respect of the proclamation within two months from the date of publication of the said proclamation in the Official Gazette;

And whereas the said proclamation was also published in a Newspaper as required under sub-section (3) of section 3 of the Pondicherry Municipalities Act, 1973;

And whereas the objections and suggestions received within the prescribed period from the residents of Oulgaret Commune Panchayat were considered by the Government in detail and the Government has been pleased to decide that those objections have to be over ruled;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 504 of the Pondicherry Municipalities Act, 1973 and all other powers enabling him hereunto in this behalf, the Administrator of Pondicherry hereby declares the entire local area under the jurisdiction of Oulgaret Commune Panchayat to be a Municipality with effect from 14th January, 1994.
